Cancellations made by March 26, 2023, will receive a full refund <u>less \$25.00</u> administration fee.
Cancellations March 27 - April 19 will have an <u>additional \$25.00</u> charged as a late cancellation fee.
Cancellation must be received by Email, Mail or Text.
Cancellations after April 19 will not receive any refund.
